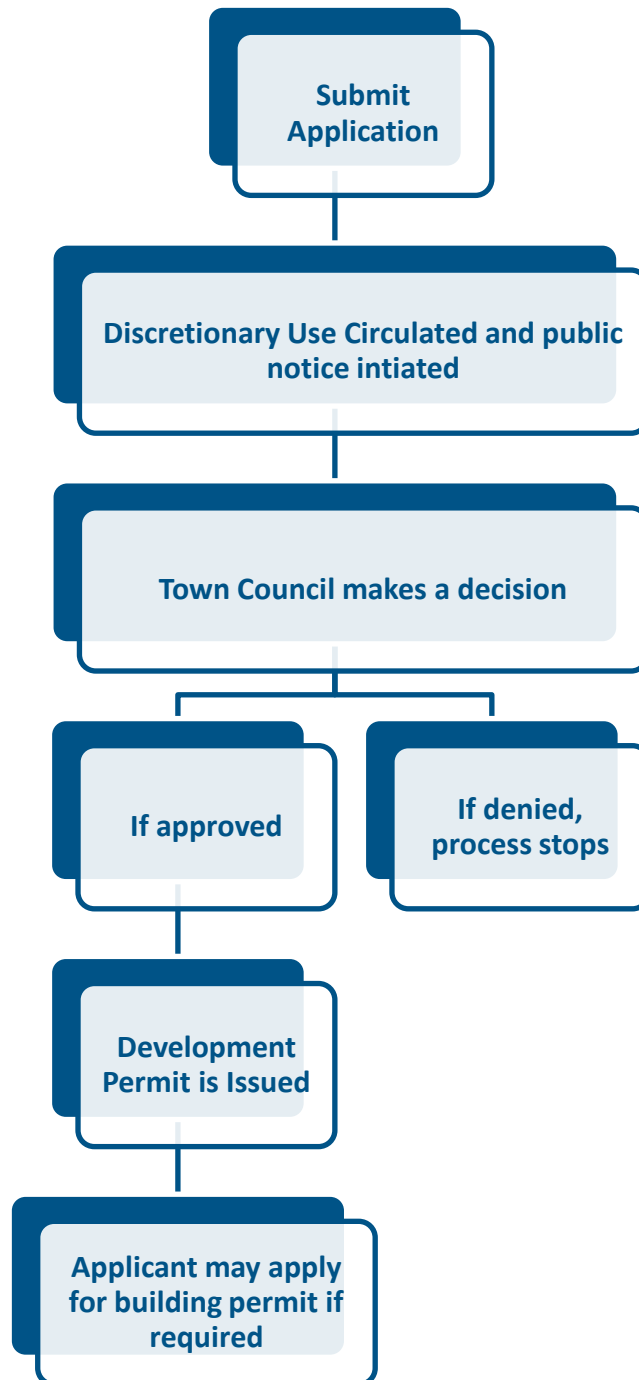


Discretionary Use Process





DISCRETIONARY USE APPLICATION

The Town of Pilot Butte has two categories of uses that may be accommodated in each zoning district:

Permitted Uses – a use or development to which an owner is entitled to a development permit provided the use or development confirms to the applicable development standards and regulations in the zoning bylaw.

Discretionary Uses - a use of land, building or other structure that may be permitted in a zone only at the discretion of and at a location specified by Town Council.

Application Requirements

The following is required:

- 1. A completed application form with all questions answered and signed by the applicant and the owner (if different);

Accuracy of information provided on the application form is critical to a legal and binding decision. Be as accurate as possible.

- 2. A cheque payable to the Town of Pilot Butte of \$20.00 to reflect the cost of the application fee;
- 3. An 8.5 x 11 set and one electronic set of the floor plans.
